



PRESENTER'S AGREEMENT – 2CCR-FM 90.5

1. I will comply with all codes, regulations and legislation relevant to **Radio Station 2CCR-FM and** community broadcasting stations, and undertake to read and comply with any rules, regulations and station policies which are communicated to me in writing.
2. I accept responsibility for the content of my program, and I agree to comply with media law requirements including defamation, contempt of court, copyright and anti-discrimination laws as communicated to me in writing.
3. I recognise that in addition to **Radio Station 2CCR-FM** under law I may also be liable for actions, suits, claims, losses and/or damages as a result of my comments or conduct on air.
4. I agree to accept directions and decisions made by the Management of **Radio Station 2CCR-FM on:** program content including sponsorship announcements; presentation and technical quality; on-air conduct; access to station premises; use of station equipment and property; strategic planning; risk management; and Occupational Health & Safety.
5. I will comply with any reasonable changes in broadcast times as required by Management.
6. I agree not to promote any sponsor until and unless that sponsor has entered into a signed sponsorship agreement with the station and paid the appropriate sponsorship fee.
7. In relation to the transmission of my program I agree to:
 - a. Endeavour to be at the station premises, ready to present my program a minimum of **15** minutes before broadcast time;
 - b. Provide a replacement presenter approved by Management if required;
 - c. Provide a pre-recorded program at least three hours before broadcast time;
 - d. Inform Management, within 48 hours, of any complaint concerning my program or any incidents that might lead to a complaint.
8. I acknowledge that material broadcast on **Radio Station 2CCR-FM is** the property of the station, and that such material may only be sold or broadcast to other outlets with the permission of Management. I accept that when such material is sold to an outlet on a commercial basis the proceeds will, in general, be shared 50/50 between the station and the program maker/s.

9. I accept that **Radio Station 2CCR-FM** retains the ownership and copyright of all works which it specifically commissions e.g. Station and Sponsorship Announcements. As a volunteer, I retain copyright of all other works that I create for broadcast.

10. I accept that **Radio Station 2CCR-FM** will take every care with recorded material left by me at the station but cannot accept any responsibility for loss or damage.
11. I will treat other volunteers, guests of the station, staff and Management with consideration and respect. I will not, without the prior approval from Management comment publicly on the operation of **Radio Station 2CCR-FM** or of any staff member or volunteer.
12. I will treat station equipment, facilities and property carefully. I will use station equipment and facilities for the production and preparation of my program and for no other purpose without the prior consent of Management. I will not remove station equipment or property on any occasion without first having obtained permission from Management.
13. I will not make commercial representations on behalf of **Radio Station 2CCR-FM**, to any person or organisation without prior written authority from the Board.
14. I agree that a breach of the above listed conditions may result in the suspension of my broadcast rights and may, in some situations, lead to the termination of my broadcast rights. I acknowledge **Radio Station 2CCR-FM's** grievance procedures as the appropriate avenue for conflict resolution.
